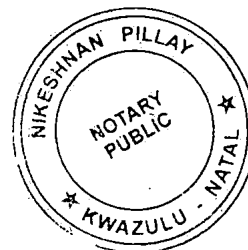

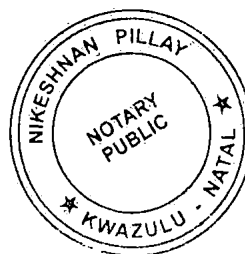

4. The accrual system referred to in Chapter 1 of the Matrimonial Property Act No. 88 of 1984 ("the Act") shall not apply to their intended marriage.

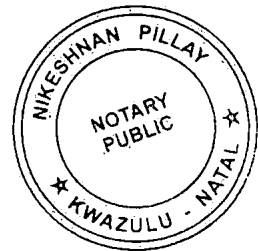




